Entries must be postmarked by 10/4/22 for discounted rate. Entries submitted via Federal Express or Express Mail will be accepted only if the signature waiver is signed. No telephone, e-mail, or fax entries will be accepted. Any changes to entries, including cancellations, will be accepted until 10/4/22. Changes must be made to the Secretary by telephone, e-mail, or in writing. **Cancellations received after 10/4/22 will not be eligible for a refund of fees. After closing, 1/2 entry fees will be refunded IF there is a signed and dated note from a veterinarian stating the dog should NOT compete,**

All dogs must be registered with C-WAGS to participate in the C-WAGS classes and receive credit. See FEO rules. Day of show registrations will be accepted. See registration form in premium, if needed.

Awards

Qualifying ribbons will be awarded to each team who qualifies. Placement ribbons will be awarded to the top 4 high scoring team in each class. Other special awards and prizes may be offered.

C-WAGS Notice to Exhibitors

Competitors, through submission of entry, acknowledge that they are knowledgeable of C-WAGS Obedience & Rally rules and regulations including but not limited to the following rules regarding entry:

- ♦ All exhibitors are expected to treat the judges, trial hosts, your canine partner and all other exhibitors with respect.
- ♦ All judges and trial hosts are expected to show respect to all exhibitors.
- ♦ This trial is open to all dogs registered with C-WAGS.
- ♦ Trial Hosts may elect to accept FOR EXHIBITION ONLY entries of non-registered dogs.
- ♦ Teams may be entered in multiple levels/classes at the same trial.
- ♦ Dogs must be shown by a member of the owner's immediate family.
- ♦ Collars: The dog must wear a flat type collar (buckle, snap or proper fit martingale) and/or body harness in the ring. Electronic training collars are not allowed on the show grounds.
- ♦ Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge
- ♦ Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs. Do not let your dog go up to crated dogs. Do not let your dog get in another dog's way.

In addition,

- ♦ The organizing committee may refuse any entry for any reason.
- ♦ THERE SHALL BE NO REFUND for entries in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal. There will be no refunds if the trial has to be cancelled for any reason.
- ♦ Refunds will be made for females in season upon written request accompanied by a statement from the exhibitor's veterinarian.
- ♦ Returned checks do not constitute a valid entry. There will be a \$35.00 service charge for returned checks. Payment of entry fees and service charges shall be made by money order within 7 days of notice to exhibitor of returned check. Any fees not received within 7 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible.
- ♦ All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes.
- ♦ Dogs must be on leash while on show grounds unless being shown.
- ♦ Please pick up after your dog and yourself.

Directions to Canine Affair Center:

From the West—Take 480 E to 271 N to Mayfield Rd. East. **OR** Take 90 E to 271 S to Mayfield Rd. East. Stay out of the Express Lanes.

Take Mayfield Rd. to Rte 306 (Chillicothe Rd). Head North to Mulberry Rd. Turn Right on Mulberry Rd. As you are heading east on Mulberry Rd, turn at the driveway before the large sign for Aerotech. Follow the long driveway around a curve to the right to the buildings in the back. Canine Affair is on the left end of the building on the left.

From the East—Take Rte 80 West to 44 North to 422 East to Rte 306 (Chillicothe Rd.). Head north through the townships of Newbury & Chesterland. Turn right on Mulberry Rd. **OR:** Take Rte 90 West to Rte 306 (Chillicothe Rd). Head South through Kirtland. Turn left on Mulberry Rd.
